- Funding Letters (scholarship or loan) must indicate recipient's name, include specific amount of funds, duration of funding, be on official agency letterhead, include agency contact information, signed/ dated by appropriate official, and stamped or sealed with official seal.
- Financial Documents which are not acceptable include: Investment funds, Stocks, or Non-Liquid Assets.
